



Photo/Video Release Agreement

I expressly release and indemnify Help-Portrait, Inc. and its parents, subsidiaries, affiliates, officers, shareholders, members, directors, employees, successors, assigns, licensees, representatives, insurers, and agents from and against any and all claims, losses, damages, expenses and costs, including attorneys' fees, known and unknown, arising out of or in any way connected with the above granted uses and representations.
